1. OVERVIEW

1.1 By signing up for, training and participating in any of the sporting & recreational activities, events and / or tournaments (collectively referred herein as “Activities”) provided by **CENTAURS GROUP PRIVATE LIMITED**:

(i) I hereby signify that I have read and understood this Disclaimer; and

(ii) I hereby agree and consent to the terms in this Disclaimer set forth by

CENTAURS GROUP PRIVATE LIMITED, its staff, contractors and / or authorised agents and organisers (collectively referred herein as “CG”).

2. RISK ACKNOWLEDGMENT

2.1 I understand that I / my child / my ward will be exposed to the ordinary risk of injury and hazardous weather conditions.

2.2 I agree to ensure that I / my child / my ward will comply with any instructions and rules provided by CG before and during the Activities to mitigate such risk.

2.3 I acknowledge and accept that CG will take all reasonable precautions and exercise reasonable care to ensure the safety of me / my child / my ward before and during the Activities.

2.4 I declare to the best of my knowledge that I / my child / my ward have not suffered any illness, bodily injury or physical impairment which might make me / him / her / us more susceptible to the risks of the Activities.

2.5 I confirm that I / my child / my ward / we are not pregnant.

3. PERSONAL INJURY INSURANCE REQUIREMENT

3.1 By participating in this activity/programme/event, you acknowledge and agree that it is your sole responsibility to ensure that you and your family members are covered by adequate personal injury insurance. The organisers and affiliated parties are not

responsible for any injuries, accidents, or medical expenses that may occur during participation.

We strongly recommend that all participants review their insurance policies to ensure their children are covered for personal injury in the event of an accident. By attending or engaging in this activity/programme/event, you release the organisers, sponsors, and all associated entities from liability for any injuries, damages, or claims that may arise.

4. INDEMNITY

- 4.1 I acknowledge and accept that in the event of any losses to properties and / or any injuries sustained by me / my child / my ward in the course of or in connection with the Activities thereof (save for personal injury or death resulting from the negligence of CG), I / he / she / we shall not hold CG responsible for any loss, damage or injuries or death resulting thereof.
- 4.2 I hereby waive all and any claims, loss or damage whatsoever in respect of me / my child / my ward against CG (save for personal injury or death resulting from the negligence of CG).

5. ACTIVITIES

- 5.1 For the avoidance of doubt, the aforementioned Activities shall include those listed on the CG Websites (www.centaursgroup.com) i.e. Rugby, Touch, Netball, Events, of which covers recreational and competitive training, matches, leagues, tournaments as well as multi-sport Pit Parties and holiday camps hosted by CG and / or other clubs / schools.
- 5.2 You are encouraged to check back periodically or to contact CG for details of any changes and / or new Activities.

6. PAYMENTS, REFUNDS & CANCELLATIONS

- 6.1 Centaurs Term Fees for Rugby or Netball ("Sport") are non-negotiable and cannot be paid in part by a customer ("Member"). Term Fees must be paid ahead of the specified Term Start date and late payment will attract an admin fee. Failure to pay might preclude your child from taking part in the Sport and Centaurs Group taking further action.
- 6.2 For new Members who join once a Term is underway, we will charge pro-rated fees; those Members will pay full Term Fees for subsequent Terms.

6.3 Centaurs is unable to offer refunds or credit for missed weeks of training within a Term, except in the circumstances set out below:

a) If a child has an ongoing, serious injury or illness backed up by a medical certificate which states they must miss three (3) or more consecutive weeks of a Term, Centaurs will be happy to offer a credit of fees for the time they are out of play. We will carry this credit forward to the next term. Please note that credit for fees will expire within 12 months, unless requested by the Member in writing prior to that expiry date.

b) In the case of unhealthy levels of Haze resulting in three (3) or more consecutive training sessions being cancelled, we will refund or credit 75% of the fees paid for those cancelled sessions (with the unrefunded 25% covering admin costs). Please refer to Appendix A below for cancellation triggers.

c) Centaurs Group will be not be liable for any failure or delay in performing an obligation under this Agreement that is due to any of the following causes, to the extent beyond its reasonable control: acts of God, accident, riots, war, terrorist act, epidemic, pandemic, quarantine, civil commotion, breakdown of communication facilities, breakdown of web host, breakdown of internet service provider, natural catastrophes, governmental acts or omissions, changes in laws or regulations, national strikes, fire, explosion, generalised lack of availability of raw materials or energy. Upon Force Majeure we will, to the extent possible, communicate with members via email promptly to advise our proposed course of action.

6.4 We make every effort to ensure that Members enjoy their experience at Centaurs. From time to time, however, a child may be withdrawn from the Sport by their parents because they are not enjoying the Sport or the Sport does not meet the expectations of the parents. Please talk to us if this is the case and we will try our best to resolve any issues. No refunds will be made if a parent willingly withdraws a child during a Term, except in the case of a medical necessity, as outlined above.
